## Subject: Revision of the norms of assistance under the Scheme of Assistance to National Sports Federations – regarding

The guidelines for the Scheme of Assistance to National Sports Federations (NSFs) were formulated in 2001 vide Order No.6-6/94-SP.III dated 14.08.2001, with a view to providing financial assistance to the NSFs recognized by the Ministry of Youth Affairs & Sports (MYAS). The Government has been extending financial assistance through this Scheme to the NSFs for sport development activities across various areas like training, competition conduct and participation in international competitions. These guidelines also contained various instructions relating to functioning of NSFs, their recognition by the Ministry, good governance practices, anti-doping measures and categorization of sports disciplines, etc. The instructions were revised / amended from time to time.

2. Norms of assistance under the Scheme of Assistance to NSFs were revised vide circular No.8-53/2010-SP.III dated 10.6.2011 and further revised vide circular No. 12-5/2013-SP-III dated 4.11.2015. The last revision of the norms was done vide circular of even number dated 28.02.2022. The revisions to the Scheme in 2015 and 2022 have mainly focused on increasing the quantum of support provided under each component in response to the inflation of cost of products and services. Further, the scheme has also been revised to ensure more focus is accorded to supporting functions for sports development such as coaching and technical support staff, administrative staff of federations, etc.

3. As it is primary responsibility of the NSFs to promote and develop their specific sports disciplines, NSFs have to take all steps for promotion and development including generating funds and resources. The NSFs are required to raise their own resources as well to finance their operations. The financial support available under the Scheme of Assistance to NSFs is only supplemental in nature. The sports development ecosystem in India has evolved significantly since the launch of the scheme and several avenues for support for NSFs are now available including financial support extended by corporate houses. Further, there is a plethora of academies operated by the private sector and State sport departments which offer NSFs opportunity to enter into partnerships for talent development. In recognition of the availability of additional sources of support, it is important to ensure that the support received from the Government is utilized judiciously and to monitor the performance of the NSFs across all parameters relevant for development of a particular sport. Additionally, it is important to

encourage higher accountability and professional administration in the NSFs to achieve the plans which they propose at the time of requesting funding under this scheme.

4. With the objective of undertaking a holistic approach, it is desired that NSFs work in a planned manner to ensure proper governance structure at all levels, carry out all obligatory activities for development of Sports and ensure development of high performance to ensure podium finishes at international level events like Olympics, Asian Games, World Championships. NSFs will be required to submit a detailed proposal with plans for developing their respective sport across all relevant areas of sports development. The detailed plans proposed by the NSFs shall be aligned to a **4-year Olympic cycle** as per the best international practices. The plan would include periodic milestones within the cycle. The proposal will include the funding requirement for the entire 4-year cycle, broken into annual budget estimates and their performance will be monitored in two years cycle.

5. Further, the NSFs will need to provide annual financial statement of their entire operations while approaching the Governing for assistance under the Scheme. The statement will include sponsorships, grants, etc. received by the NSF and head-wise expenditure statement for all areas of operation. Additionally, to ensure data management, performance monitoring, sports science evaluation etc, the use of dedicated centralized web portal is the need of the hour. For the same, the NSFs are mandated to use IT systems for record management.

For addressing and quickly resolving the logistical/financial issues of the Indian contingent and taking care of the emergent situations which may arise during the multi-sports events or other major international events, which may be beyond the activities and norms mentioned in this Circular, Committee headed by Secretary (Sports), Financial Advisor of the Ministry of Youth Affairs & Sports and Director General, Sports Authority of India will consider and approve the requisite assistance. Expenses on send-off of teams, interaction programmes, felicitation of teams, sports awards functions will be incurred from the Scheme of Assistance to NSFs.

9. All NSFs availing assistance under the Scheme must clearly reflect the logo of the MYAS/SAI at all prominent locations including digital platforms, apparels of the sportspersons wherever permissible as per international norms. Any Guidelines, issued by the Ministry/SAI, with regard to branding for the assistance received from the Ministry/SAI, shall be followed by NSFs. NSFs should prominently display the funding received from the Government as well from other sources on their website as well as the Social Media platforms.

10. All other provisions under the Guidelines of Assistance to NSFs, such as category of sports disciplines, entitlement limits, etc. shall be governed by the instructions issued by the Ministry from time to time. Availability of assistance or otherwise under a specific component of

this Scheme to a particular NSF will depend on factors like its entitlement as per its category (High Priority, Priority, General), its current performance, availability of resources under the Scheme and assessment of its functioning. Indian traditional sports shall be treated as part of High Priority disciplines and the classification of existing sports disciplines as traditional sports will be decided by the Ministry with the approval of Minister In-charge of Youth Affairs & Sports.

11. Provisions of the Scheme can be relaxed/revised in consultation with IFD and with the approval of the Union Minister in-charge of Sports provided the basic nature and scope of the relevant provisions of the scheme are not altered and provided the relaxation/ revision does not require changes in budgetary allocation of the scheme.

12. In case any clarification is required on any provision of or any matter relating to implementation of the Scheme, the same will be referred to the Ministry of Youth Affairs and Sports, Government of India, whose decision in the matter shall be final.

13. This issues with the approval of Hon'ble Minister for Youth Affairs & Sports and comes into force from the date of issue of this circular.
