Monthly Report for the month of April, 2024**Name of the Ministry / Department: Department of Sports****1. Important policy decisions taken and major achievements during the month:**

- a) As a special effort to encourage the participation of women in sports, the ASMITA Women's Leagues in various sporting disciplines are being organized under the Khelo India Scheme. As a part of this, 05 leagues in multiple sports disciplines including Cycling, Archery and Football were organized for different age groups.
- b) As a part of the joint effort to advance the anti-doping science and research, the Memorandum of Understanding (MoU) between the National Dope Testing Laboratory (NDTL) and the CSIR-Indian Institute of Integrative Medicine (IIIM), Jammu, has been extended for three more years. This cooperation will also enable further strengthening of the reference standard synthesis activity and in achieving excellence in the field of dope testing in sports.
- c) A multi-national training camp was organized in Rohtak between 19th March and 2nd April 2024, with the participation of 169 pugilists from India, Kazakhstan, Sri Lanka and Uzbekistan. The camp was supported by REC Limited, making it part of the proactive initiatives by the government to actively engage Public Sector Enterprises and private institutions to contribute to the development of sports in the country.
- d) The 'Fit India Champions' podcast series titled 'Fitness Ki Baat Champions Ke Sath' has been showcasing inspiring stories of the sporting heroes of India. In April 2024, podcasts featuring Equestrian Anush Agarwalla and Indian Paralympian javelin thrower Sumit Antil were broadcasted on platforms such as YouTube, Facebook, Spotify etc. The podcast series is inspiring the audience to adopt a physically active and healthy lifestyle through the journey of these athletes.
- e) A webinar was organized on 26.04.2024 on the Prevention of Sexual Harassment Act, 2013 with the active participation of various stakeholder in the sporting fraternity including the athletes, coaches and employees of the department, its educational institutions and autonomous bodies. Over 500 participants attended the webinar which is an initiative to create a safe environment for women in workplace and to sensitize various stakeholders on women's safety.
- f) The National Anti-Doping Agency (NADA) organized 33 Anti-Doping Education Awareness programmes across the country during the month of April 2024.
- g) The State rounds of the 3rd edition of the Fit India Quiz were held between 26th March and 10th April 2024.
- h) The 130th, 131st, 132nd and 133rd Meeting of Mission Olympics Cell (MOC) were held on 04.04.2024, 10.04.2024, 18.04.2024 and 25.04.2024 respectively on various components of Target Olympic Podium Scheme (TOPS). Proposals from various athletes belonging to various sporting disciplines worth Rs. 2,86,34,206 were approved.

- a) Swachhta Campaigns are organized regularly in the office premises of the National Anti-Doping Agency (NADA), National Dope Testing Laboratory (NDTL), Sports Authority of India (SAI) Head Office and SAI Regional Centres across the country with the active participation of the staff.
- b) Cleanliness drives are regularly organised at Lakshmibai National Institute of Physical Education (LNIPE) under the Swachhta Abhiyan.
