Monthly Report for the month of March, 2024

Name of the Ministry / Department: Department of Sports

1. Important policy decisions taken and major achievements during the month:

- a) In an important step towards recognizing and incentivizing our athletes for their performance in major sporting events, comprehensive reforms have been made by the Department of Personnel and Training (DoPT) in consultation with the Department of Sports, in the process of recruitment of athletes for government jobs and their promotions. The inclusion of the Khelo India Games in the ambit of eligibility criteria for sportspersons applying for government jobs is a major step towards giving strategic importance to the games and in creating viable career opportunities for athletes during and post their active athletic career.
- b) The Khelo India Rising Talent Identification (KIRTI) programme was launched with the twin objectives of identifying young talents from all parts of the country and leveraging sports as a tool to curb addiction to drugs and gadgetry distractions. The initial phase of the programme has been launched across 50 sports centres in India to assess 50,000 applicants for 10 sports disciplines. Through the programme, it is aimed to carry out 20 Lakhs assessments throughout the year through notified Talent Assessment Centres across the country.
- c) On the occasion of International Women's Day (IWD) on 8th March, 2024, the establishment of two new National Centres of Excellence (NCoEs), exclusively for women, was announced by the Hon'ble Minister of Youth Affairs and Sports. Various events were organized by the Ministry of Youth Affairs & Sports and the Sports Authority of India including a cultural program, a webinar, and recreational events with the active participation of women athletes and employees.
- d) To encourage the participation of women in sports, the ASMITA Women's Leagues are being organized throughout the year for various sports disciplines across the country. As a part of this initiative, a total of 17 League competitions and 2 Talent Hunt events in various sports disciplines were organized for women athletes of different age groups.
- e) The results of the preliminary phase of the 3rd edition of the Fit India Quiz were announced on 8th March, 2024. 256 schools have qualified for the ongoing State-level rounds of the Fit India Quiz.
- f) The 125th, 126th, 127th and 128th Meeting of Mission Olympics Cell (MOC) were held on 29.02.2024, 07.03.2024, 14.03.2024 and 21.03.2024 respectively on various components of TOPS. Proposals from various athletes belonging to various sporting disciplines worth Rs. 2,15,43,446 were approved.
- g) The Department of Sports has been taking various initiatives to strengthen the sports governance ecosystem of the country. As a part of this, a workshop was organized on 22.03.2024 at the Major Dhyan Chand Stadium, New Delhi, to sensitize the officials of National Sports Federations (NSFs) and SAI, on the Prevention of Sexual Harassment Act, 2013 (PoSH) and the Right to Information Act, 2005 (RTI). The workshop was organized hybrid with active participation of representatives from various NSFs and, officials of DoS and SAI.

- h) As a part of strengthening India's international outreach initiatives, especially through sports cooperation, the Department of Sports hosted an eight-member delegation from Bhutan during their visit to India between 11.03.2024 and 17.03.2024, to explore avenues of bilateral cooperation in the realm of Sports between the two countries. The delegation visited various institutions in Delhi, Bangalore and Gwalior and, interacted with various stakeholders in the Indian sporting ecosystem including senior officials of DoS, SAI, NSFs and the Indian Olympic Committee.

- a) Swachhta Campaign is organized regularly in the office premises of the National Anti-Doping Agency (NADA) and the National Dope Testing Laboratory (NDTL).
- b) Through Swachhta drives, campuses of SAI Regional Centres across the country are cleaned, sanitised and disinfected regularly.
- c) The premises of Lakshmibai National Institute of Physical Education (LNIPE) including the sports facilities and residential blocs are cleaned every month under the Swachhta Abhiyan.
