NOTICE INVITING - Transportation of urine & blood samples from various locations in India to WADA Authorised Laboratory at various locations.

Scope of Work

The National Anti Doping Agency (NADA) which is an autonomous body of the Ministry of Youth Affairs and Sports is taking concrete steps to discourage and prevent Indian athletes and sports persons from using doping substances. The main objective of NADA anti doping rules and programme are to preserve the integrity of sports in India and protect clean athletes.

NADA invites sealed tenders under two bid system for engagement of courier agency for Transportation of urine & blood samples from various locations in India to any other WADA accredited laboratories as under:-


- (i) Qatar
- (ii) Belgium
- (iii) Dresden (Germany)
- (iv) Athens
- (v) NDTL New Delhi
- (vi) Any other WADA accredited Lab where transportation cost is minimal

Duration Of Engagement

The term/duration of engagement shall be for a period of twelve(12)months. NADA decision in this regard shall be final & binding on the bidder.

Technical requirement

1. Should be specialized in transport of Biological samples.
2. Should be able to provide cold chain transport facility.
3. Should have validated/ approved packing materials.
4. Should have integrity, identity and security system for each consignment.

5. Should have facility to pick up from the locations or as advised by NADA 24 hours in advance. Consignment will contain dope samples and documents. Dope samples will have to be delivered to specified Laboratory and documentation has to be delivered to NADA Office separately. No separate charges shall be payable for delivering the documents/papers to NADA Office
6. Custom clearance and other charges and taxes are to be included in the financial cost while submitting the bids.
7. Temperature Data Logger is to be used for each consignment during transport of dope samples to Laboratory.
8. Consignment must be delivered within 72 Hrs in case of urine samples and within 36 hrs in case of blood samples.
9. The selected agency shall be intimated 24 hours in advance to pickup the sample from the desired location and the destination of the samples to be delivered.
10. In order to ensure timely delivery of the samples to WADA accredited Laboratories, agency may also suggest at least 3 convenient days in a week of the pickup (to avoid delay due to Holiday) so that dope testing may be planned accordingly. If no days are suggested it will be presumed that all days of the week are equally feasible for the agency.
11. On receipt of communication from the NADA for sample pickup, selected agency may give advance notice to the laboratory for the sample delivery so that delay not happen in clearance.

Sample/bottle description

Urine - Each kit contains two bottles, dimension of kit are given below:-

Length 14 cm, height – 17 cm, width – 08 cm


Blood - Each kit contains two bottles, dimension of kit are given below:-

Length 06 cm, height – 17 cm, width – 05 cm

Approximate weight of the sample bottle shall be 600gms for each kit.

Eligibility Criteria for the Agencies.

1. The bidder should be a registered company.
2. The bidder must have a valid PAN and GST number. Copies of which need to be submitted along with the technical bid.
3. The firm must have been in operation for handling the biological samples with at least 2 years' experience
4. Proper chain of custody is to be maintained for the consignment.
5. The agency should not be under a declaration of ineligibility for corrupt or fraudulent practices with any Government departments/agencies/ministries or PSUs.

6. The agency should have a full fledged establishment within India and an office with a dedicated team for handling the shipment at the destination.

7. The agency should be able to demonstrate its ability to execute the entire scope of work.

8. The quotations should be submitted in two bids i.e (1) Technical as per Annexure I (2) Financial bid as per Annexure II.

9. The bidder should not have any pending dispute with NADA. The bidder shall also submit a no claim certificate, if it has worked for NADA earlier.


10. The bidder is required to submit performance certificates from atleast 2 major Departments/organizations where services were provided in last one year. Moreover it shall submit a complete list of Govt Departments/agencies for which they have provided services during 2019-20 and 2020-21.

Terms & Conditions.

- A. The bidder shall not sublet whole or part of the work to any other agency.
- B. The bidder shall deliver the consignment to the complete satisfaction of the laboratory and NADA.
- C. No payment will be released for consignment in case of failure to transport that consignment within specified period as indicated at point 8 of technical requirements.
- D. An amount of ten times of the invoice for the consignment will be imposed in case of lost/misplaced/damaged consignment as penalty.
- E. There will be no variation in price quoted during the period of the contract and shall be irrespective of any foreign exchanges rates fluctuation.
- F. Bills should be preferred on monthly basis along with documentation of chain of custody and successful delivery of consignment to the Lab.
- G. NADA reserves the right to terminate the contract at any point of time by giving a notice if the services are found to be not satisfactory. No compensation will be entertained on account of such termination.
- H. TDS will be deducted as per the applicable rates.

Security Deposit.


Earnest Money Deposit(EMD) / Bid Security for Rs 2,00,000(Rupees Two Lakh Only) drawn in favour of the DDO, NADA, New Delhi to be submitted in an acceptable form such as Demand Draft from a scheduled Bank. If the Pre-Qualification is not accompanied by EMD/Bid Security, the proposal of the agency shall be rejected outright. No interest shall be payable by this office on the sum deposit as EMD. The EMD security of unsuccessful bidders would be returned within one month of issue of work order/contract to the successful bidder. The EMD should be valid for at least 60 days from the date of the closing of the tender document.


