- 5. Directorate of Sports and Youth Welfare, Government of Madhya Pradesh shall release the funds along with State share to the block and village level implementation agencies within 15 days of receipt of funds from Central Government.
- 6. The sanction is being issued in exercise of the powers delegated and in conformity with the rules and principles as approved by the Ministry of Finance. It is also certified that the pattern of assistance has the approval of the competent authority.
